A few of their other queries have had to do with overall future plans which are taking somewhat more time to prepare since we are still in the process of finalizing them ourselves.

In the meantime HQ is having our lease with the City checked by their

legal staff and our loan agreement

with the City is also being reviewed.

As things now stand it is felt that HQ is far more amenable now than they were in the past with regard to many of the things we would like to do. Consequently the Staff still believes that we should seriously consider the advantages of remaining a part of the CAF.

All of the reasons we wanted to be a part of the organization in the first place are still valid. In addition, there are any number of benefits available to us as part of the CAF, not the least of which are our present and potential relationships with other CAF groups. We should also consider the fact that there are dozens of organizations out there that would consider an alliance with, or donations to, or cooperation in general, with a CAF group that would not even look twice at a brand new local museum.

This does not mean that there should be a dissolution of the EWB Museum at all. It exists and can continue to exist and could conceivably play a very important part in the future of the organization, especially if we start getting some significant gifts or donations. If, however, HQ decides that they are willing to work out a mutually beneficial basis for cooperation with us and what we want to accomplish, there are some very strong reasons for continuing to be the Estrella Squadron of the CAF.

Some indication as to what HQ will agree to should be forthcoming very soon, so hang in there and in the meantime...

... In the Meantime, Let's Get With It!!!

Regardless of what we ALL decide to do about the CAF/Museum question we can STILL go ahead with our plans for the building complex right now and this is what we should be doing.

The final building plans to be presented to the City are now on hand. The Building Committee has been re-energized and will take a close look at the updated plans and drawings to make sure that they are as required. At that point the plans can be finalized with the City and we can get a PERMIT to begin to build! The City has given us every assurance that they will push the permit through as soon as possible so we could conceivably be moving dirt and preparing foundations in a few weeks!

For the benefit of everyone we are including a reduced copy of the site plan as it was submitted. As you are aware, there are some slight modifications to the plan in the interest of economy.

The entire concrete pad for the whole display/storage area will be cast first with all future plumbing stubbed in. The building will be erected as soon as possible thereon in the same size as was taken down; approximately 80' wide by 65'. The front or "leanto" section, which will include offices and rest rooms, will be put up immediately thereafter as finances permit. The other end will also be extended

somewhat later, again, as finances permit. This will get us under cover, even better than we are now, and out from under rent payments.

The Building Committee will also try to put together a workable plan concerning what has to be done before we actually start building. This will include a final cleanup at the almond plant, taking down the pole barn (if that is the plan) and putting together a group that will supervise the new construction.

It is the fervent hope of the Committee that most of those who comprised the crew at the demolition site can be prevailed upon again to head up the supervision of the construction crew at the new site.

Everyone is aware by now that, in the final analysis, the work that was done at the almond plant was eventually shouldered by a relatively few members.

Now that we all have been baptized by various fires, however, it would seem that we as a group should be able to see the tremendous potential offered by our new site and renewed goals. This should be enough in itself to fire up the enthusiasm that has been allowed to slip a bit in the past few weeks.

We will get this work done and if one needs to see what can be accomplished by just a few, take a ride by the almond plant and remember what was there in December of last year.

We still have the promise of getting the boys from the School and the boys themselves have told us on more than one occasion that they are really interested in helping out. There are also some highly qualified people among the members of our group and we earnestly hope that they will help guide our progress.

Let us put the problems of the past behind us. We can solve whatever remains in short order to the satisfaction of almost everyone. We have nothing but positive potential ahead of us and the chance to be proud of ourselves as a cohesive group.

Let's do it.






